TRUSTEES' REPORT

The trustees submit their report and accounts for the year ended 30 April 2021.

Structure, Governance and Management

The Society is an unincorporated association with its own constitution.

The trustees comprise the members of the Society Committee, who are recruited by seeking appropriately experienced volunteers amongst the membership. Committee members are appointed at the Annual General Meeting. The current members of the Committee are listed on page 1.

The management of the Society is carried out entirely by the Committee.

No remuneration was paid to any members of the Committee. Members are reimbursed for expenses incurred, as many of the Society's expenses have to be paid for immediately by cash or personal card.

Objectives and activities

The principal activity of the Society is to advance the education of the public in the art of drama by the presentation of public performances and other related activities.

This objective is usually achieved by producing plays on a regular basis, which are performed in local venues. The COVID-19 pandemic has significantly limited both the activities of the Society and its ability to generate income in the last financial year.

Achievements and performance

The year started for the club during the COVID-19 lockdown, with our previously planned March 2020 production of 'Calamity Jane, The Musical' currently postponed until October 2021.

In the summer of 2020, script reading and casting took place for 'Roaches Coaches', a comedy series written by FADS member Ian Kidd. Ian had originally intended this to be a screenplay, but re-worked his scripts into a podcast format so it could be produced by the club under lockdown restrictions. Episode 1 was recorded and produced by Sam Yoffe in the autumn using a small studio, compliant with social distancing restrictions, and released in early December. This was followed by two short vignettes. With a further lockdown from January, Episode 2 was rehearsed and recorded entirely online and in performers' homes using Zoom and via subscription to an audio recording service called Clean Feed. Episode 2 is currently in production with plans for Episode 3 later in the year.

In March, FADS member Gavin Paterson submitted an entry into the SCDA Monologue Competition. The monologue, written by Mike Tibbetts, was titled 'The Pseudo-Passive Transponder' and was rehearsed and recorded by Gavin entirely at home.

The SCDA was unable to run a One Act Play festival in the Spring and, after much discussion, the remaining regional and national finals scheduled for later in 2021 were cancelled.

We had several online social events for members and friends, including a 'Christmas Capers' celebration, Burns Quiz night in January and a gin tasting evening in February. Tony Flisch hosted two popular Zoom evenings titled 'FADS: The Early Years', curated from his vast collection of photos and video footage of past productions.

We have continued to invest/update equipment including purchase of studio and mobile recording equipment, which has been used this year by the Roaches Coaches production.

Committee and AGM

Three office bearers and five ordinary members were elected to serve in 2020/2021 at the AGM, held via Zoom on 27 October 2020.

This year the Club had 36 adult members, 3 juniors and 3 primary-aged children. This reduction in active membership reflects the significant downturn in production and performance opportunities during the 2020-21 year.

Financial Review

The results for the year show a deficit of £2,285 which decreases our funds carried forward to £5,770. This deficit reflects a significant decrease in income during a year with no ticketed productions, where affiliation, rental and insurance costs remained constant. It is also worth noting income from membership fees was at 65% of the figure for the 2019/20 year.

The net income from performances was £0 as opposed to £4,209 in 2019/20.

Reserves policy

It is necessary for the Society to hold a sufficient level of reserves to meet expenditure on productions, most of which has to be paid before any income is received from the performances.

Committee responsibilities

The Committee acknowledges its responsibilities for:

- ensuring that the Society keeps proper accounting records that disclose with reasonable accuracy at any time the financial position of the Society and to enable them to ensure that the accounts comply with the Charities and Trustee Investments (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 and the provisions of the constitution;
- (ii) safeguarding the assets of the Society and taking reasonable steps for the prevention and detection of fraud and other irregularities;
- (iii) preparing a Trustees' Annual Report and accounts in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice and
- (iii) confirming that an audit will not be required for this year.

REPORT OF THE INDEPENDENT EXAMINER TO THE MEMBERS OF FINTRY AMATEUR DRAMATIC SOCIETY

I report on the accounts for the year ended 30 April 2021 set out on pages 4 and 5.

Respective responsibilities of committee and reporting accountant

As described on page 3, the Committee is responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investments (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).
